he Surigao del Sur Water District Association conducted its monthly meeting on February 7, 2011 at Carmen WD although it was hosted by Madrid WD. General Managers from different water districts in Surigao del Sur attended the said meeting, namely: Engr. Menillo C. Siega (Bislig), Engr. Ruben C. Elpa (Tandag), Mr. Wilfredo Sanchez (Lianga), Ms. Lucille R. De la Torre -OIC from Madrid, Engr. Jose Hilario V. Pandili Jr. from Hinatuan, Mr. Segundino B. Buniel from Cantilan and Engr. Jilberto C. Tupas from Carmen. It was the first time that the CWD attended the meeting and was formally introduced as part of the association. GM Tupas welcomed his fellow GMs and was very blissful that though CWD is a newly-created Water District, SURWADA with open-arms accepted it as a new member. In fact, GM Tupas said that it was a privileged to hold the meeting at their municipality. He further was glad to meet the General Managers from different districts. Some



of the GM gave him tips and advices in coping with several challenges that might be encountered in a newly- formed water district. Moreover, CWD BOD Chairman Aniano C. Ogdoc who was present in the meeting was introduced.

CWD was formally recognized as part of the association as it was the first time the district attended the said meeting.

GM Tupas expressed that he was glad that though CWD is a newly-created water district, SURWADA has welcomed them with open arms. He was also glad to meet the General Managers from different water districts.

During the meeting, all GMs gave him tips and pieces of advice on how to cope the challenges of a newly-created district.

Bislig City Water District Water Clarifier, now on-line



actan Rock Industries, Inc. continuously conducted testing and commissioning on the Water Clarifier. They also Implemented correction and adjustment on the facility to meet the required technical specifications and expected water output.

BCWD tapped Metropolitan Cebu Water District (MCWD). Laboratory results showed that input water from the source during heavy rain was 3,638 National Turbidity Unit (NTU) but when processed in the water clarifier, output was 6.1 NTU and when filtered at the filter basin, output was 3.8 NTU which is within the 5 NTU requirement of the National Standard for Drinking Water.

With this project, the more than 20 years of water turbidity problem on the said barangays is now a thing of the past.

Tandag WD's completed two (2) units 400 cu.m. Steel Fabricated Ground Reservoir; the first in Caraga Region

andag Water District has completed the installation of its two (2) units steel fabricated ground reservoir last year. Located in the elevated area of Brgy. Awasian, it is designed to supplement the concessionaires' water supply requirement especially during peak-hours. The completed reservoirs have helped cope the increasing water demand in Tandag.

Originally, TWD had planned to construct 800 cu.m. concrete ground reservoir but this was not implemented due to several disadvantages such as problem of site configuration, difficulty of accessing the site to deliver the needed construction materials and insufficiency of budget allocation since it has a high unit cost based on LWUA's Php21,000/cu.m.



These two (2) units reservoirs contributed to efficient and uninterrupted operation of the district. Water is stored in the tank at night and released in the

morning to increase pressure while supplying entire Tandag especially during peak-hour demand.

n March 25, 2011, Lianga WD was privileged to have Hon. Prospero A. Pichay, Jr., LWUA Chairman, Hon. Philip A. Pichay, Congressman, 1st District, Hon. Johnny T. Pimentel, Governor during

the blessing and inauguration of the completed expansion project funded by NLIF. Said activity was also participated by Tagbina Local Officials, LIWAD Board of Directors and personnel from LWUA.



On 2009, the approved Program of Works (POW) for the expansion project was P 20,504,438.06 and on September of the same year, LIWAD received an initial release of f P 14,311,510.00 from NLIF. The project was then implemented by administration and it was completed on last December 31, 2010 amounting to P 17,894,320.71, where Lianga Water District shared part amounting to which P 1,377,253.47 was equity of the district.

The project was completed through the efforts of the General Manager and Board of Directors thus providing adequate, safe and potable water supply to Brgys. of Baucawe, Anibongan, Liatimco and part of Wakat, Barobo, Surigao del Sur which guarantees adequate, safe and potable water supply. This development redounds to positive effect both from the concessionaires and financial operation of LIWAD.

Madrid Water District

a Government-Owned and Controlled Corporation (GOCC) providing local water service to the community, Madrid Water District participates to every socio-cultural activity sponsored by the municipal government.

Genesis and Growth of Cantilan WD

he formation of the Cantilan Water District was initiated by late SP Member Live M. Azarcon sometime in the last quarter of 1989 who at that time was the Municipal Mayor of Cantilan.

The legal basis of the formation of Cantilan Water District like all other water districts in the country is the Presidential Decree No. 198. Chapter II, Sec. 6. of P.D. 198 provides "This Act is the source of authorization and power to form and maintain a district."On

February 20 1990 the Sangguniang Bayan of Cantilan, Surigao del Sur passed Resolution No. 25-1990 adopting and affirming the organization of the Cantilan Water District. On May 4, 1990 the Local Water Utilities Administration thru the Board of Trustees Resolution under the Chairmanship of Trustee Benjamin E. Diokno issued the Conditional Certificate of Conformance (CCC 441) to the Cantilan Water District. The First project of the Cantilan Water District was implemented in 1993 and the project became operational



in September 1994. As the number of connection increased to 600 households in 1996, the system experienced water shortage. Due to the water shortage, the management applied for an additional loan from the Local Water Utilities Administration to develop an augmentation source; however, the latter did not grant the former an additional loan.

In as much as the LWUA did not grant additional loan, the management tried to seek financial assistance from the Hon. Prospero "Butch" A. Pichay, Jr. who at the time was

the Congressman of the First District of Surigao del Sur. Fortunately the District was given Five Hundred Thousand Pesos (P 500,000.00). Out of the Funds from the latter, CWD was able to developed the Malitangtang Pumping Station.

Sometime in 2005, CWD was able to avail the KFW loan thru the LWUA for the rehabilitation of the system; and out of this KFW loan the CWD was able to developed its Calagdaan deepwell as another augmentation source.

During the incumbency of the Honorable Prospero "Butch" A. Pichay, Jr. as Chairman of the Board of Trustees of the Local Water Utilities Administration, The CWD again became the recipient of the financial assistance from the Non-LWUA Initiated Funds (NLIF). One of the work items of this fund is the CWD administrative building. At present the construction is on-going and within this 2011, CWD will be able to have its own new building.


