



Liwad Installed Centrifugal Pump at Sitio Baribian

The Management of Lianga Water District (LIWAD) continuously operates for the sufficient supply of safe and potable water within its jurisdiction. Lianga Water District paves its objectives through the completion of the installation of Centrifugal Booster Pump 5 Horse Power, Single Phase situated at Sitio Baribian, Payasan, Lianga, Surigao del Sur. The said project is very important to fill up the reservoir supplying the new service areas of Zone VII, VIII & XI namely the Anibongan, Liatimco, both in Municipality of Lianga and Barangay Wakat, Barobo, Surigao del Sur. The said project under the Priority Development Assistance Fund (PDAF) of Honorable Congressman of 1st District Philip A. Pichay completed on July 31, 2013. With the cooperation of LIWAD Management through General Manager Wilfredo G. Sanchez and the Acting Chairman of LIWAD-BOD Dr. Editha C. Mosquera were very optimistic to take part for its realization.

The work disseminated under the approved Program of Work (POW) on May 2013 duly been verified and officially tested by the management with its specified part (the project) and corresponding allocation as follows: Pump,



Motor Control (free installation) -Php 97,000.00, Pipes & Fittings- Php 19,779.00, Pump House- Php 20,838.50, Electrical Transformer & Accessories- Php 68,457.71, Fuel-Php 7,369.00, & Labor Cost-Php 9,210.00. The Total Actual Cost arrived at Php 222,650.21. The project is a vital tool to sustain the adequate supply of safe and potable water to the said areas.

LWUA conduct CPS - 1 Training in CWD

Carmen Water District (CWD) felt very privileged for the responsive action of Local Water Utilities Administration (LWUA) in the request of CWD for the training and installation of Commercial Practices Systems I (CPS-1).

Last year 2013 the CWD had passed a resolution to LWUA requesting the latter to conduct a CPS-I training for the staff. Since then, Engr. Jilberto C. Tupas, CWD General Manager keep on follow-up to LWUA Advisor Ms. Ma. Lourdes B. Canlas to favor the said request.

Finally, the LWUA Advisor Ms. Canlas informed GM Tupas that the LWUA will sent one (1) representative in the person of Mr. Charlie E. Quejado; LWUA Management System Design Specialist that will conduct the lectures and trainings for CWD staff.

It was a one (1) day briefing, discussion and orientation about CPS installation. And then four (4) days applications and modifications of the available reports and ledgers prepared by the CWD staff.

Mr. Quejado was very systematic and comprehensive in giving all the details necessary for the district's day to day transactions

especially in recordings and making reports. Amidst working "over time" just to realize all the reports, Mr. Quejado remained very supportive and patience to the staff.

Finally, GM Tupas with his staff expressed very warmth thanks to LWUA especially to Ms. Canlas; LWUA Advisor and Mr. Quejado for helping the



district in achieving an efficient and effective management towards excellence service.

Drier Weather and El Niño threatens normal water supply in Bislig City

The drier weather of Bislig City has severedly affected the water sources of Bislig City despite occasional rainfall from April to June 2014.

The downpour failed to compensate effects of the hotter and drier weather. The early warning of the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) on El Niño heightened the call for an action plan and emergency measures to concerned agencies. Hence, Local Water Utilities Administration issued a Memorandum Circular No. 004-014 dated May 16, 2014 on El Niño Action Plan and Mitigation Measures.

The said memorandum stipulated the direction of Secretary Rogelio L. Singson of the Department of Public Works and Highways to all government agencies concerned to formulate an action plan and adopt necessary measures to mitigate adverse effects of the El Niño phenomenon towards the end of the current year till probably early next year.

All water districts are required to undertake the following: Inventory and assessment of all existing and potential sources of water supply; reduction of non-revenue water; conduct of public information activities to promote general




awareness on the need to conserve water; promulgation and enforcement of WD policies to promote conservation and prevent pilferage, pursuant to the provisions of the Water Crisis Act; and coordination with all concerned government agencies and private non-government organizations for the successful implementation of the plan.

With these directives, BCWD continuously conducted radio advertisement campaign on water conservation, plant more trees, use cloth bags and don't burn plastic to help mitigate El Niño as well as Climate Change as Bislig City is already experiencing the impact of the hotter and drier climate.

Ribbon Cutting Ceremony and Blessings of Liwad Fire Hydrants

Last June 04, 2014, Lianga Water District (LIWAD) held a Ribbon Cutting Ceremony and Blessings of the new installed Fire Hydrants situated at Lianga Market Mall, P-1 National Hi-Way & Barangay Diatagon Terminal. The program started at 8 o' clock in the morning at Lianga Market Mall the blessing was fervently commemorated by Father Frank Felter, Parish Priest of the locality. LIWAD Employees and Board of Directors led the Ribbon Cutting Ceremony. Also present was the Municipal Mayor Honorable Roy Hegino G. Sarmen who witnessed and grace the said occasion. There also the representatives from Bureau of Fire Protection FO3 Rolando C. Daano, Purok 1 President Leo Tripoli, & Market Mall Caretaker Antonio Cotiangco.

One LIWAD employee from Operation/Technical Section disseminated the manual operation of Fire Hydrant opening. This will be useful during emergency purposes. The said demonstration will also trained the apprehensive representative to open the Fire Hydrants so that in the absence of LIWAD employee there is a well-oriented and trained individuals who can open the Fire Hydrant. The management will assure the 24/7 availability of Fire Hydrants keys at LIWAD Administration Building.



The installation of Fire Hydrants in three (3) different areas was made possible thru the Priority Development Assistant Project (PDAP) of Honorable Congressman Philip A. Pichay. The Program of Work (POW) officially tested and verified by the Management on January 2014. The project or specific part with corresponding amount appropriated as follows: Pipes and Fittings- Php 102,547.88, Construction Materials-Php 1,431.00, Painting Php 665.00, Welding & Fabrication Php 600.00, Labor Cost Php 11,730.00. A Total Actual Cost amounting to Php 116,973.88. This new project signifies a pace of development of the district obtaining Corporate Social Responsibility and uplifts the security of the locality from the inevitable or beyond the control fire situations.



A part of the district commendation to the concessionaires whom does not only brings joy but also to motivate the on-time payment of the water bills. Lianga Water District celebrated the relevance of the operation as it started from 1979. 

MADRID expansion program

Through another memorandum of understanding, Madrid WD and Brgy. Magsaysay Officials seek to further enhance their partnership in public service by providing safe drinking water to the people of Sitio Teguis in Brgy. Magsaysay.

The local officials requested pipes from the Provincial Governor's Office and the WD provided the labor, fittings and other materials needed to connect additional pipelines from the mainline.

In order to encourage new concessionaires, the MWD Board of Directors amended the service connection policy wherein new applicants need only to pay P 500.00 monthly for five (5) months instead of paying the installation fee outright.



TWD employs WBCS

Tandag Water District (TWD) established Water Billing and Collection System (WBCS), technology known to be highly effective and efficient in the billing and collection process. The system, now ten years in operation, has been continually improved to keep pace with recent development and need of concessionaires.

WBCS was designed to perform quick billing, collection, data management of concessionaires' accounts including the reading of water consumption. In terms of billing, unlike before, it would only take a day to read and bill one to two service coverage areas. And the 6,006 total active service connections would not be over 15 days for two meter readers to complete the tasks giving consumers more than enough time to check their respective water bill.

The latter, labeled as Notice of Collection features information on their service connection, billing, metering and even shows chart of their consumption for 12 months. A barcode was configured for each consumer's bill for a timesaving collection process, as it facilitate a speedy action, and thus avoiding queuing during payment period.

Through this technology, the tedious manual operation of data gathering and recording of water consumption has been made a lot faster and less complicated. In effect, concessionaires

THE MAKING OF HINATUAN WATER DISTRICT



The Municipal Council or Sanguniang Bayan of the Municipality of Hinatuan passed a resolution creating Hinatuan Water District under S.B Resolution No. 517, which is a mandate under President Decree No. 198 known as the Local Water Utilities Act of 1973 on May 12, 1980,

The first Board of Directors meeting was held on July 26, 1980, the composition of the BOD are the following; Chairman-Mr. Jaime R.Sullano, Vice Chairman – Mr. Armando M. Barrios, Secretary – Mrs. Carmen O. Nazareno, Member – Mr. Enrique Chu, Member – Mr. SabinoVillaluz. The first General Manager was Mr. Francisco Jabagat.

On November 6, 1980, the Conditional Certificate of

Conformance (CCC) No. 143 was issued to Hinatuan Water District (HWD) by the Local Water Utilities Administration (LWUA) legalizing the existence of HWD.

The Local Government Unit of Hinatuan turned over some facilities in which these became the first facilities of HWD, to wit: spring source from Barangay Tagasaka and a deep well from Barangay Sasa, with a small transmission line of almost six (6) kilometers in length. The system can not suffice the water needs of the municipality and have problem on the water quality.

The district applied a loan from LWUA in 1986 that led to the construction of a new system and is operational until now.

In 1995, the management of HWD was taken over by LWUA and was managed by Interim General Manager coming from LWUA in the person of Engineer Alex Bulicatin, then on 1997 a new Manager was hired in the person of Engineer Jose Hilario V. Pandili, Jr. a civil engineer by profession and resident of the Municipality.

In 2007, a Php 5.0 million project was granted of HWD fro JICA (Japan International Coordinating Agency) which now serves Barangay Bitoon.

The present set of the Board of Directors of HWD are; Chairman – Mr. Maurice Jose Y. Villaluz, Vice Chairman – Mrs. Lily V. Balbuena, Secretary – Mrs. Janelle P. Nazareno, Member Mr. Juan V. Viola, Member – Mrs. Erlinda R. Borgueta.

Meet the new General Manager of the Cantilan Water District

The new General Manager of the Cantilan Water District is Mr. Vicente Cirilo Arreza Iriberri. He is popularly called "Tinty" by his siblings, relatives, peers and friends. "Tinty" is a true-blooded Cantilangnon. He is the son of the late Mr. Canico Puyales Iriberri and Mrs. Adelfa Carmen Arreza Iriberri. He is married to Janise Ann Quintos Iriberri of Cagayan de Oro City and blessed with five(5) children, namely: Jan Vincent (27), Cyril Ann (23), Karla Monica (18), Vicente Cirilo III (16) and Nick Matthew (11).

"Tinty" finished his elementary education at the Cantilan Pilot School in 1970 and secondary at the Saint Michael College in 1974. He received his bachelor degrees in Business Administration, major in economics from the Philippine School of Business Administration (PSBA, Manila) and Bachelor of Laws from Manuel L. Quezon University (MLQU, Manila). He is also a graduate of Master of Business Administration (MBA) from Saint Paul University Surigao (SPUS).

Office No. 10, based in Cagayan de Oro (1989–1992); General Manager of the CarCanMadCarLan Aquamarine Multi-Purpose Cooperative(1992-1998); Project Assistant of the Integrated Rural Financing (IRF) Program of the Land Bank of the Philippines, Tandag Branch (1994-1998); member of the Sangguniang Bayan of Cantilan (1998-2001); On-site coach under the joint DAP Sa Mindanao-PC-LGSP Local Development Management Project (2001); Area Project Coordinator of the Lanuza Bay-wide Environmental Planning Project which was managed by the Orient Integrated Development Consultants (OIDCI) and funded by PC-LGSP (2002); Program Officer of the Philippines-Canada Local Government Support Program (PC-LGSP, 2002-2004); Part-time College Instructor of various management subjects at Saint Michael College and Surigao del Sur Polytechnic State College (SSPSC, now SDSSU); Executive Director of the Lanuza Bay Development Alliance (2009-2010); School Administrator of the Hotchkiss Learning Center (2010-2012); and Executive Director of the Cantilan Bank Foundation, Inc. from 2010 to 2013.

The new manager is not new in the management and operations of the district being the Chairman of the Board of Directors of the Cantilan Water District effective upon his appointment as replacement director representing the Education Sector in November, 2011 and designated as Officer-in-Charge on May 21, 2013 to November 14, 2013.

Mr. Iriberri was appointed as regular General Manager (under coterminous status) by the Board of Directors effective November 15, 2013, duly confirmed by the Civil Service Commission (CSC).

The new manager is also active in civic and cause-oriented non-governmental organizations as past President/Chairman of the Cantilan "Tilang" Jaycees; the Bardugs Association of Cantilan, Inc.; CarCanMadCarLan Bay Watch Foundation, Inc.; the Rotary Club of Central Surigao based in Cantilan, and the Cantilan Multi-sectoral Forest Protection Committee. He is currently member of the Regional Advisory Committee (RAC) for Mindanao of the Foundation for the Philippine Environment (FPE) and a volunteer of the Gawad Kalinga Foundation Inc.

TWD conducts soft-opening of 2-storey multi-purpose building

Tandag Water District (TWD) initiated the soft-opening of the 2-storey multi-purpose building on June 25, 2014. The construction, which started in 2013 was funded under the Internal Cash Generation (ICG) of the District. And as of this writing, cost of the project amounted to P 4.9 M.

The simple activity kicked off with a blessing preceded by Fr. Leaonardo P. Orrillaneda. Present were members of the Board of Directors, employees and staff with Engr. Ruben C. Elpa, general manager. A board meeting followed afterwards at the conference room situated on the second floor of the multi-purpose building.

The newly built structure was designed to house the whole division of Engineering, Production & Water Quality and Watershed Management, office responsible in the construction, maintenance of services, transmission lines & distribution mains, production & water quality, and watershed management. It also served other purposes as it allocated space for storekeeping, warehouse, water meter calibration, repair and motor pool.
