The Lianga Water District (LIWAD) of Annex-A Market Mall, Lianga, Surigao del Sur through its Bids and Awards Committee (BAC), invites **PhilGEPS Membership suppliers** to apply for eligibility and to bid for the hereunder contract:

Name of Contract: Supply and Delivery of unplasticized Polyvinyl Chloride (uPVC) Pipes, fittings, Materials and Appurtenances.

Location : Lianga, Surigao del Sur

Brief Description : Supply and Delivery of uPVC Pipes ranging from 150mm to 100mm, fittings, Materials and Appurtenances

Approved Budget for the Contract (ABC): Lot 1 - ₱ 3,745,940.00

Terms of Payment: Down payment of ₱ 500,000.00 upon complete delivery and final acceptance and amortization of ₱ 270,495.00/ month for the next 12 months.

Prospective bidders should have experience in undertaking a similar project/contract within the last two years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non discretionary "pass/fail" criteria. Post qualification of the lowest calculated bid shall be conducted.
