## **Resolution No. 09 Series of 2020**

"RESOLUTION TO TEMPORARILY SUSPEND THE TEN PERCENT (10%) PENALTY CHARGE TO ALL UNPAID WATER BILL OF LIWAD ACTIVE WATER SERVICE CONNECTIONS."

- WHEREAS, OFFICE OF THE PRESIDENT PROCLAMATION NO. 929 DATED 16 MARCH 2020 "DECLARING A STATE OF CALAMITY THROUGHOUT THE PHILIPPINES DUE TO CORONA VIRUS DISEASE 2019 (COVID-19)", PROVINCE OF SURIGAO DEL SUR EXECUTIVE ORDER NO. 14, AND LGU-LIANGA DECLARATION DATED 18 MARCH 2020;
- WHEREAS, LIWAD Resolution No. 11 dated 30 April 1986 "RESOLUTION APPROVING THE POLICY IMPLEMENTING THE PENALTY OF 10% TO UNPAID WATER AFTER DUE DATE IN ORDER TO DISCOURAGE THE LATE PAYMENT":
- WHEREAS, (COVID19) is now Pandemic and a worldwide health crisis, it is but a humanitarian consideration to suspend the 10% penalty charge since water is the basic utility everyone is needing right now and the health crisis tend to conglomerate through time;
- WHEREFORE, ON MOTION OF VICE CHAIRPERSON BELLA C. BALA-AN duly seconded by ALL MEMBERS PRESENT, it was;

RESOLVED AS IT IS HEREBY RESOLVED TO TEMPORARILY SUSPEND THE TEN PERCENT (10%) PENALTY CHARGE TO ALL UNPAID WATER BILL OF LIWAD ACTIVE WATER SERVICE CONNECTIONS.

Resolved further, suspension the 10% penalty charge to all unpaid water bill will take effect from April to June 2020 billing.
